Trustee Marlys Kossman seconded the motion. Crisp yay, Allacher yay, Taylor yay, Kindley yay, Kossman yay, Martin nay. Motion passed.
- The board discussed compensation to Tom Bredehoft on pending lawsuit. Trustee Cody Martin made a motion to table until next meeting after talking to the lawyer. Trustee Troy Kindley seconded the motion. Motion passed.
- Trustee Chuck Crisp made a motion to hire Sharon Rand to clean town hall. Trustee Troy Kindley seconded the motion. Motion passed.
- Trustee Troy Kindley made a motion to accept the town clerk job description. Trustee Cody Martin seconded the motion. Motion passed.
