At 6:02 pm Mayor Thomas Bredehoft called the meeting to order followed by the Pledge of Allegiance.

#### **APPROVE MINUTES**

Trustee Daymond Deatrich made the motion to approve the minutes from the January 09, 2017 regular meeting. Trustee Tandi Moore seconded the motion. Motion passed and carried.

#### **OLD BUSINESS**

1. A draft ordinance was presented for review to create a liquor tasting permit. This ordinance will be on the agenda 3-13-2017.

2. Stan Kimble had sent a draft agreement between the Town of Flagler and Cortxia for review. After review Trustee Witt suggested changing the length of time given to have construction complete from 120 day to 180 days. The council agreed. Trustee Tandi Moore made the motion to send the draft agreement to Cortxia for review with the change in construction time. Trustee Daymond Deatrich seconded the motion. Motion passed and carried.

## **NEW BUSINESS**

 Della Calhoon and Sheriff Tom Ridnour were present to discuss the tornado sirens. Kit Carson County Emergency Office is suggesting testing the sirens on a monthly basis. Discussion was held regarding the process. Siren testing will be on the second Tuesday of each month March through October 2017.

2. Les and Dana McDaniel were present to introduce themselves to the council. Les and Dana explained they had moved to Flagler from Denver. They own a construction company ( All Colorado Exteriors) and are interested in being the building inspection for the Town of Flagler.

- 2. Crisp reported cold patching was continuing as weather permitted.
