5. A Tasting Permit Application for Reliable Enterprise was presented by Clerk King. Trustee Chuck Kinkel made the motion to approve the Tasting Permit Application by Reliable Enterprise.

6. Les and Dana McDaniel presented some information to the council regarding the effect of building codes on payments from insurance companies. McDaniel does not feel the Universal Building Code which Flagler uses is enough to protect a customer during an insurance claim.
