

**RESOLUTION No. TOF RES- 155**

**CHANGE UTILITY CONNECTION FEE FROM \$25.00 TO CONNECTION DEPOSIT \$200.00  
AND ADD DUMPSTER RENTAL DEPOSIT TO \$200.00 AND ADD DUMPSTER RENTAL FEE  
\$20.00 AND CHANGE WATER TAP FEES FROM COST OF MATERIALS + \$200.00 TO COST  
OF MATERIALS + \$830.00**

**THE BOARD OF TRUSTEES OF THE TOWN OF FLAGLER, KIT CARSON COUNTY,  
COLORADO, DO HEREBY RESOLVE TO CHANGE UTILITY CONNECTION FEE FROM \$25  
TO CONNECTION DEPOSIT \$200, ADD DUMPSTER RENTAL DEPOSIT \$200, DUMPSTER  
RENTAL FEE \$20. CHANGE THE WATER TAP FEES FROM COST OF MATERIALS + \$200  
TO COST OF MATERIALS + \$830.00**

WHEREAS, the Town of Flagler, (hereinafter referred to as the "Town"), in the County of Kit Carson and the State of Colorado, is the body corporate operating as a statutory town pursuant to the general statutes of the State of Colorado; and

WHEREAS, the Town provides essential utility services, including water, sewer and trash collection; and

WHEREAS, the Town has determined that the establishment of a utility/equipment rental deposit is a reasonable and equitable measure to ensure the timely payment of utility bills; and

WHEREAS, the Town provides Flagler Non-Residents Trash Collection services and the option to rent a dumpster; and

WHEREAS, the Town operates the water, sewer and trash service as an Enterprise Fund, and

WHEREAS, as being an enterprise, it is determined that it is appropriate to charge a fee for dumpster rental; and

WHEREAS, the Town has deemed it necessary to adjust the water tap fees to accurately reflect the actual costs of providing water service to new connections and maintain the financial viability of the water system; and

WHEREAS, the Town has not raised the water tap fees since February 14, 2000.

NOW THEREFORE BE IT RESOLVED by the Town Council of Flagler, Colorado that a utility service or equipment rental deposit of \$200 shall be required for all new utility service accounts and, under specific conditions, for existing accounts, as outlined herein.

BE IT FURTHER RESOLVED that the deposit shall be held by the Town until such time as the customer has established a satisfactory payment history, typically defined as 12 consecutive months of on-time payments, after which the deposit shall be refunded without interest as determined by the Town Counsel.

BE IT FURTHER RESOLVED that in the event of account closure, the deposit shall be applied to any outstanding balance, with any remaining funds refunded to the customer.

NOW THEREFORE BE IT RESOLVED by the Town Council of Flagler, Colorado that a equipment rental fee of \$20 shall be charged to all customers renting a dumpster.

NOW THEREFORE BE IT RESOLVED by the Town Council of Flagler, Colorado that a Water Tap Fee in the amount of Cost + \$830.00 shall be charged for all new connections to the Town's water system.
