RESOLUTION CHANGE TRASH SERVICE SCHEDULE AND RATES

THE BOARD OF TRUSTEES OF THE TOWN OF FLAGLER, KIT CARSON COUNTY, COLORADO, DO HEREBY RESOLVE CHANGE THE TRASH SERVICE SCHEDULE AND RATES FOR FLAGLER RESIDENTS INSIDE AND OUTSIDE THE INCORPORATED LIMITS OF THE TOWN OF FLAGLER BEGINNING MARCH 1, 2026.

WHEREAS, the Town of Flagler, (hereinafter referred to as "Town"), in the county of Kit Carson and the State of Colorado, is the body corporate operating as a statutory town pursuant to the general statutes of the State of Colorado; and

WHEREAS, the Town provides for the community trash service, and

WHEREAS, the Town operates the trash service as an Enterprise Fund, and

WHEREAS, the Town has determined the relationship between the cost of providing the service and receipts for sale of service is disproportionate, and

WHEREAS, as being an enterprise, it is determined that the rates should be increased to offset the imbalance, and

WHEREAS, the Town has determined that the trash service schedule be modified to ensure minimal service disruption and afford proper equipment maintenance for longevity.

NOW, THEREFORE, BE HEREBY RESOLVED BY THE BOARD OF TRUSTEES FOR THE TOWN OF FLAGLER, STATE OF COLORADO THAT THE FOLLOWING MONTHLY RATES FOR TRASH SERVICE INSIDE AND WITHIN 1-MILE OF TOWN LIMITS BE:

Residents will rise from \$23.81 to \$30.00

Business high volume will rise from \$59.93 to \$98.00

Business medium volume will rise from \$44.51 to \$65.00

Business low volume will rise from \$24.95 to \$35.00

and;

THAT THE FOLLOWING MONTHLY RATES FOR TRASH SERVICE IN EXCESS OF 1-MILE UP TO 5 MILES OF INCORPORATED TOWN LIMITS BE:

3 yard dumpster \$40

6 yard dumpster \$60

8 yard dumpster \$90

and;

THAT THE FOLLOWING TRASH SCHEDULE BE:

Weekly, Monday through Tuesday: Businesses and residents inside incorporated Town limits and within 1 mile of Town limits.

Weekly, Friday: Businesses inside and within 1 mile of Town limits.

Monthly, Last Friday: Businesses and residents exceeding 1 mile within a 5-mile radius of incorporated Town limits.

Adopted at the meeting of the Board of Trustees of the Town of Flagler, Colorado, on this 12th day of January 2026, and effective March 1, 2026.
