

RESOLUTION 160
Adopt Mill Levy for 2026

A RESOLUTION CERTIFYING AND LEVYING THE MILL LEVY OF THE TOWN OF FLAGLER FOR 2025 TO DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF FLAGLER FOR THE 2026 BUDGET YEAR AND AUTHORIZE AND CERTIFY MILL LEVY RATE TO THE BOARD OF COUNTY COMMISSIONERS OF KIT CARSON COUNTY.

WHEREAS: The Board of Trustees of the Town of Flagler, has adopted the annual budget in accordance with the Local Government Budget Law (Part 1 of Article 1 of Title 29, C.R.C. as amended); on December 11, 2025, and

WHEREAS: Section 39-5-128 (1), C.R.S. requires the Town of Flagler to certify its 2026 mill levy to the Board of County Commissioners of Kit Carson County no later than December 15, 2025, and

WHEREAS: This amount of money is necessary to balance the budget for General Operations purposes from property tax revenue, and

WHEREAS: The valuation for assessment for the Town of Flagler as certified by County Assessor of Kit Carson County is \$5,877,462.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF FLAGLER, COLORADO APPROVE MILL LEVY OF 41.640 MILLS.

Section 1:

Pursuant to Section 39-5-128 (1) and 39.1.111.5 C.R.R. as amended, the Town of Flagler hereby certifies to the Board of County Commissioners of Kit Carson County that the Town's 2026 Mill Levy on all taxable property within the City shall be as follows:


Section 2:

That for purpose of meeting all general operation expenses of the Town of Flagler during the 2026 budget year, there hereby levied a tax of 41.640 mills upon each dollar of the total valuation for the assessment of all taxable property within the Town of Flagler for the year 2026.

Section 3:

That the Mayor is hereby authorized and directed to certify to the County Commissioners of Kit Carson County, Colorado, the mill levies for the Town of Flagler, as herein above determined and set, based upon final certification of valuation from county assessor.
